De.mem Receives Project Award

10 September 2019: Australian-Singaporean water and waste water treatment company De.mem (ASX:DEM) ("De.mem" or "the Company") is pleased to announce that it has secured a project (undisclosed sum) for the delivery of a water treatment plant.

The water treatment plant is based on a membrane process and will be delivered containerized.

The execution of the order starts with immediate effect. The customer is ACCIONA, a leading international group involved in the development and management of infrastructure and renewable energy.

The project award leads to an increase of De.mem group's contracted revenues for CY 2019 of approx. 10-15%, depending on the extent of revenue recognition from the project prior to calendar year end according to accounting principles. Contracted revenues include:

- Revenues already recorded up until today; plus
- Revenues yet to be recognized during the remainder of CY 2019 from contracted projects, including this new project award;
- Revenues yet to be recognized during CY 2019 from the recurring business lines of the company, ie. its service business (Build, Own, Operate & Operations & Maintenance contracts), and the expected sales of replacement components and consumables which are of stable and recurring nature.

It follows the award of a A\$2.8 million desalination plant project to De.mem in April 2019, which is also based on a (Reverse Osmosis) membrane process. Hence, the order further confirms Demem's technical excellence and capability in supplying the highest standard of membrane based water treatment plants.

The project award continues our revenue growth momentum in CY 2019."
